FY24 Budget Review

The Board reviewed a report providing an update -- as of April 30, 2024 (with two months remaining in the fiscal year) -- on the DDI budget for FY2024 (July 2023 through June 2024), including individual items approved by the Executive Board.

The FY24 budget approved by the Executive Board was \$178,586, with expected revenue of \$94,500 and an overall loss of \$84,086. Details of FY24 projected revenue, projected expenses, and the projected project ending fund balance as of June 30, 2024:

FY25 Budget -- Funding Requests + Budget Approval

Included in the Executive Board's financial responsibilities is the role of making "decisions on allocation of funds for innovative work and testing." Each year, the Executive Board solicits funding requests for the upcoming fiscal year (July through June). Past funding has supported meetings, workshops, training, and tools development, among other activities.

One key benefit of Full membership discussed is getting to determine the direction of the Alliance (a "golden ticket").
