

# 2010 Annual Report of the Data Documentation Initiative



## Focus on Tools and Software

Tools development for DDI started to take off in a big way during the past fiscal year. A variety of promising tools emerged and the implementers of these tools began to collaborate and share information. To facilitate these interactions further, the DDI Alliance will focus on bringing implementers together during the next year with the goal of making tools interoperable and modular.

The Data Documentation Initiative (DDI) is an effort to develop an international XML standard for social science metadata. The effort is sponsored by the DDI Alliance, a group of organizations representing the data archive, data producer, and data user communities.

Fiscal year 2010 was a notable year for the Alliance in many ways, and below we highlight a sample of the year's important events:

- The Australian Bureau of Statistics joined the Alliance during the year and invited Alliance experts to consult with ABS on full implementations of both DDI and SDMX. The goals of ABS in using DDI are to (1) collaborate with other organizations in the development of new methods and systems to support the production and use of statistics and (2) promote more effective sharing of existing leading practice solutions among agencies.
- Training at Dagstuhl in Wadern, Germany, was again sponsored by GESIS – Leibniz Institute for the Social Sciences and the DDI Alliance. Attendees learned about "Using DDI 3 to Support Preservation, Management, Access, and Dissemination Systems for Social Science Data."
- Another Dagstuhl workshop focused on important DDI use cases. Participants collaborated on a set of papers that were published as part of the ICPSR Working Paper Series. These papers, available on the DDI Web site, cover a diverse set of use cases, from creating a DDI editing tool to using DDI for comparison purposes. All DDI Working Papers have Digital Object Identifiers and share an ISSN number.
- At the International Association for Social Science Information Service and Technology (IASSIST) annual meeting, held in June at Cornell University, many DDI tools were demonstrated and discussed. Interest in DDI among developers was apparent and led to the proposal for a meeting of developers to take place in the Hague in December in conjunction with the European DDI Users Group meeting.
